What are the regulations relating to waste batteries?

The specific obligations in relation to waste batteries depend on their type, but all require registration with the appropriate environmental regulatorvia the National Packaging Waste Database.

Are battery producers responsible for reducing harmful effects of waste batteries?

Battery producers are responsible for minimising harmful effects of waste batteries on the environment, by: It's illegal to send waste industrial or vehicle and other automotive batteries for incineration or to landfill.

What if I receive unmarked waste batteries from the Ministry of Defence?

If you receive unmarked waste batteries from the Ministry of Defence, assess and treat them as you would all other batteries. Marked waste batteries from the Ministry of Defence are outside the regulations. A battery or accumulator is a source of electrical energy generated by direct conversion of chemical energy and is either one or more:

What is the batteries directive?

The Batteries Directive seeks to improve the environmental performance of batteries and accumulators(rechargeable batteries) and of the activities of all those involved in the life cycle of batteries and accumulators, ie producers, distributors, end users and those involved in the treatment and recycling of waste batteries and accumulators9.

How do member states deal with waste batteries and accumulators?

Member States shall, having regard to the environmental impact of transport, take necessary measures to maximise the separate collection of waste batteries and accumulators and to minimise the disposal of batteries and accumulators as mixed municipal waste in order to achieve a high level of recycling for all waste batteries and accumulators.

Are battery energy storage systems subject to environmental permitting?

DEFRA is planning to bring battery energy storage systems (BESS) into the environmental permitting regime. However, some operators may be unaware that they may be subject to it already, putting themselves in potential legal jeopardy.
