

What is the warranty on a battery?

The battery will be covered by a 2 year standard warranty from the date of purchase, any additional warranty is offered as a pro-rata limited warranty, if your battery becomes faulty after 2 years a replacement battery can be purchased with a staggering discount.

What is the warranty on Exide Batteries?

The label on every Exide battery specifies the total number of months covered by the free replacement period and the Pro-Rata period for batteries fitted in private cars, multi-utility vehicles*, two-wheelers, inverters, gensets and solar applications. In all cases the warranty is applicable from the date of sale to the original purchaser.

Why are batteries sold with a warranty?

Batteries are sold with a warranty against premature failure due to manufacturing or material defects only. Due to the high quality of standards of the technical and manufacturing processes, the number of batteries that fail due to manufacturing defects is negligible. The most common battery problem is a flat or poorly charged battery.

What is the warranty period for a product?

The Warranty period for any Goods is as specified on the Company's website and catalogue current at the time of acceptance of the Customer's order and commences on installation of the Goods. This warranty applies to all applicable products purchased from an authorised wholesaler.

Is a car battery warranty transferable?

Your car battery guarantee isn't transferable between vehicles. Batteries used in a commercial or professional application, such as taxis, driving instructors, emergency services, works vehicles, etc., are not covered by the full term of the warranty but instead come with a 6 month warranty. How does the guarantee work?

Both product ranges come with a 3 year parts and labour warranty when purchased through Specialist Power Systems. (Standard warranty is 1 year)
