

# Foreign investment in Chilean battery companies

Is Chile ready for a battery storage project?

Battery storage projects cannot come soon enough for Chile. While Chile has been at the forefront of renewable energy generation growth in Latin America for close to a decade, that growth has most recently undergone serious growing pains.

### Which companies are investing in Chile?

Posco Holdings and petrochemical unit LG Chemsaid they are reviewing various investments or options in regions including Chile, while battery unit SK On said it is looking closely at the country. All three companies said no decisions have been made.
