There are several government grants and incentives available for the installation of solar panels in the UK. ECO4 is a government-backed scheme worth £4 billion designed to improve the energy efficiency of the least energy efficient households in the UK.

Are there government grants for solar panels?

There are no government grants specifically for solar panels, but are more steered towards improving energy efficiency. All is not lost, though, as some grants can be used to install them as part of energy efficient upgrades.

Does a solar panel grant apply to a householder?

£; The householder receives certain benefits If solar panels will only supply electricity for things like lights, TVs and computers then the grant does not apply. The Smart Export Guarantee (SEG) means that if solar panels generate more power than you use, large energy suppliers must pay you back for it.

How much can a business save on solar panels?

Businesses can receive funding for up to 20% of the cost of their solar panel system installation. As of 1st May 2023, solar panels are now available with 0% VAT, resulting in a saving of approximately £1,000 on installation and a yearly saving of £500 on electricity bills.

There are a number of government grants for solar panel users across Europe, which proves the growing importance of solar energy and how governments are trying to encourage people to make the most of solar energy.

Can you get a grant for solar panels in the UK?

This applies to every country in the UK except Northern Ireland. From April 2023 to March 2025, 45 local authorities in England can give grants of up to £10,000 to homeowners in their area for improvements including solar panels. These grants are also available for insulation, heat pumps, double glazing, solar thermal and heating controls.
