#### Are lead batteries recycled?

Lead batteries are "the world's most recycled consumer product," according to the International Lead Association, a London-based trade body. Thanks to recycling, we barely mine lead any more. A man smelts lead that has been " informally" recycled from batteries in Pesarean, Indonesia.

# How much lead acid batteries do EU countries export?

Data released to the public on April 2 from the International Lead Association and EUROBAT revealed that EU member states collectively export around EUR2 billion (\$2.2 billion)of lead acid batteries alone to countries outside the bloc, including Russia.

# What happens if you recycle a lead-acid battery?

Inappropriate recycling operations release considerable amounts of lead particles and fumes emitted into the air, deposited onto soil, water bodies and other surfaces, with both environment and human health negative impacts. Lead-acid batteries are the most widely and commonly used rechargeable batteries in the automotive and industrial sector.

# How much lead does a battery contain?

The batteries contain large amounts of lead either as solid metal or lead-oxide powder. An average battery can contain up to 10 kilogramsof lead.

# How many lead batteries are recycled in India?

A study published last year by Toxics Link, a New Delhi-based NGO, found that about 90 percentof lead batteries in India ended up recycled by the informal sector. The study mapped neighborhoods in major cities, such as Delhi, where workshops recycling lead batteries operate apparently with no official oversight.
