Which countries import solar cells to the EU?

In 2022 and 2023,imports of solar cells to the EU were almost exclusively from China. In 2024 to date, China's share of solar cells imported to the EU has fallen by around 20 percent. Over the same period the value of solar cells imported into the EU has dropped significantly (Figure 8a).

#### What percentage of solar panels are made in the EU?

Eurostat data shows that 7,19% of the solar panels in the EU in 2022 was manufactured in the EU, while 92,81% was imported. Of the imported solar panels,95,98% was produced in China. If we look at all the solar panels (both EU-produced and imported), then 89,1% of all the solar panels deployed in the EU in 2022 was made in China.

#### Which countries import solar panels?

o Note: Europe figure includes EU,Norway,Switzerland,Serbia,North Macedonia and Kosovo. Both the EU and the USare heavily reliant on imports to meet solar PV demand,each running a trade deficit for solar PV modules and cells of about \$20 billion in 2023 (Figure 6).
