## Will Indonesia impose a 200-percent import tariff on Chinese goods?

TEMPO.CO, Jakarta - Indonesia will soon impose up to a 200-percent import tariff on Chinese goods to mitigate the effects of the ongoing trade war between China and the United States. Indonesia's Trade Minister Zulkifli Hasan said on Friday, June 28, 2024, that the policy will take effect once the related regulation is issued.

The Indonesian government is considering a review of the export levy on Crude Palm Oil (CPO). Indonesia will soon impose up to a 200-percentimport tariff on Chinese goods to mitigate the effects of the ongoing trade war.

How much will RCEP reduce customs tariffs in Indonesia?

"With the certificates of origin under the Regional Comprehensive Economic Partnership (RCEP),our goods will enjoy a tariff reduction of nearly 20,000 yuan(RM12,977) when clearing customs in Indonesia," said Liu Ning,director of the company's export customs affairs. The batch of goods were valued at 430,000 yuan (RM278,994).

Can the US impose a 200% tariff on Chinese goods?

"The United States can impose a 200% tariff on imported ceramics or clothes; we can do it as well to ensure our MSMEs (micro, small and medium enterprises) and industries will survive and thrive," Zulkifli said, adding that the tariff for China goods will range from 100 to 200% and the policy will take effect once the regulation is passed.

The president-elect has also proposed a 60% tariff on all Chinese imports and a 10-20% tariff on imports from other countries under his presidency. For battery raw ...
