Only a maximum of fourcan be sent, with two per container, and each battery must have a rating of below 100 watts per hour. Can I ship a lithium ion battery by air?

For this reason, any battery that is suspected or known to be defective (swelling, corroding or leaking, for example) is not permitted for shipping within the DHL Express network.
