Goods must be labelled as "Lithium Ion Battery" or "Lithium Metal Battery" and include appropriate shipping marks and hazard labels. What are the shipping requirements for lithium batteries?

Only a maximum of four can be sent, with two per container, and each battery must have a rating of below 100 watts per hour.
