The short answer is yes, you can ship lithium batteries overseas. Lithium batteries are classed as 'Dangerous Goods', which means there are certain limitations on how they can be shipped. A charged lithium battery can, under very particular circumstances, catch fire.

Does FedEx ship lithium batteries?

FedEx adheres to IATA regulations for shipping lithium batteries by air and ADR regulations for shipping lithium batteries by road in Europe. Regulations on how to ship lithium batteries vary depending on which type you are shipping. Typically found in watches and cameras, they contain metallic lithium and are also called primary lithium batteries.

Can lithium batteries be shipped in bulk?

Lithium batteries are classed as 'Dangerous Goods', which means there are certain limitations on how they can be shipped. A charged lithium battery can, under very particular circumstances, catch fire. This means that if you ship charged lithium batteries in bulk, there's an increased risk of fire on the vehicle that is shipping them.

What are the shipping requirements for lithium ion batteries?

In addition, lithium-ion cells and batteries shipped by themselves must be shipped at a state of charge not exceeding 30% of their rated capacity. Lithium batteries are dangerous goods, and all of the regulatory requirements must be complied with, as set out in the Lithium Battery Shipping Regulations.

Do you ship e-bikes with lithium ion batteries?

Generally, we are unable to shipE-bikes containing lithium ion batteries as they are over 100 wh in size, we are not accredited to ship this size of battery on their networks. These are also classified as vehicles if shipped with the battery inside.

Can I ship a lithium ion battery by air?

For this reason, any battery that is suspected or known to be defective (swelling, corroding or leaking, for example) is not permitted for shipping within the DHL Express network.
