Do you need planning permission to install solar panels?

Current rules that require businesses to apply for planning permissionif solar panels will generate more than one megawatt of electricity will also be scrapped, meaning organisations will be able to install more solar panels on rooftops without the delay and cost of applying for planning permission.

Does government support solar?

It sets out that government is supportive of solarthat is "co-located [footnote 80]with other functions (for example, agriculture, on shore wind generation, or storage) to maximise the efficiency of land use".

Can solar panels be installed without a planning system?

Changes to permitted development rights rules will mean more homeowners and businesses will be able to install solar panels on their roofs without going through the planning system. Currently those who have to go through the planning system are having to wait over eight weeks and face extra costs.

Why is solar a key part of the government's strategy?

2.10.9 The government has committed to sustained growth in solar capacity to ensure that we are on a pathway that allows us to meet net zero emissions by 2050. As such, solar is a key part of the government's strategy for low-cost decarbonisation of the energy sector.

How does the UK support solar?

2.10.12 Government is also supporting solar through the Contracts for Difference Schemeand will include it in future rounds. 2.10.13 Solar farms are one of the most established renewable electricity technologies in the UK and the cheapest form of electricity generation.
