What is Tesco's largest solar power purchase agreement?

The 15-year power purchase agreement(PPA) with grocery retailer Tesco is the largest solar corporate PPA executed in the United Kingdom to date, claims project owner Quinbrook.

When will Tesco's solar power purchase agreement become operational?

The project, which began construction in early 2023, is set to become operational in early 2025. Tesco's 15-year Power Purchase Agreement represents the largest solar corporate PPA ever agreed in the UK.

Does Tesco & Shell have a solar power purchase agreement?

The agreements, signed with Tesco and Shell, cover 100% of the project's expected power generation. Additionally, the agreement with retailer Tesco is the largest solar corporate power purchase agreement (PPA) executed in the UK to date, Quinbrook said.

Tesco's 15-year Power Purchase Agreement represents the largest solar corporate PPA ever agreed in the UK. Cleve Hill is projected to generate enough renewable power annually to meet the equivalent electricity needs of 144 large Tesco stores.

What is Tesco's largest UK Power Purchase Agreement (PPA)?

Tesco has today announced the signing of its largest UK Power Purchase Agreement (PPA), facilitated by EDF, securing 65% of the solar power generation from Cleve Hill Solar Park. Cleve Hill, located on the north Kent coast, is the largest solar and battery storage project ever constructed in the UK, with a capacity of 373 megawatts (MW).
