How long do I have to return a faulty item?

For most items, you have up to 14 days to notify them of a return, then up to 14 days after that to send it back. There are some exceptions. See full info on shopping online. If items are faulty, it doesn't matter where you bought them. You will usually be entitled to a refund, repair or replacement, depending on when you find the fault.

Can You Change Your Mind & return store-bought goods?

You DON'T have a legal rightto change your mind &return store-bought goods. Even if you've bought the wrong colour or size, stores don't legally have to refund you simply because you've changed your mind. (It's different if items are faulty.) In reality, many shops offer more generous returns policies.

Can you return goods bought in store if you change your mind?
